**PUBLIC REPORTING.** FFAR, in its next annual report, will list all current affiliated organizations. You hereby provide consent for FFAR to include information on our website and in press releases, newsletters, annual reports, speeches, congressional reporting, fundraising activities and other public disclosures, your status as an affiliated organization.

Notwithstanding the foregoing, FFAR will notify you regarding potential communications activities and neither FFAR nor you shall use the name or logo of the other in any public announcement, press release, or other public disclosure without prior consent. FFAR and you will provide adequate notice in advance of any such publication or use for review prior to final editing or disclosure.

You may not issue press releases or any public announcements without consulting with FFAR's communications department prior to these activities. You shall send to FFAR copies of all papers, manuscripts and other materials which you produce that are related to this affiliated organization status.



In no event shall FFAR's name or logo be used directly in connection with your organization fundraising or advertising.

Nothing in this agreement implies the endorsement of either FFAR or you by the other.

In all public statements concerning FFAR, you should refer to FFAR by its full name:

In all public statements concerning your affiliation, FFAR should refer to you by your full name:

**REVOKING AFFILIATED STATUS.** In addition to the method of revocation set forth below, FFAR and your organization each retain the right to terminate this Agreement and their affiliated status with thirty (30) days prior written notice to the other.

Affiliated status with FFAR does not create a perceived or preferential relationship with FFAR. Any decision-making process regarding grants made by FFAR staff, Advisory Councils, or Board of Directors is unaffected by affiliation or lack thereof. Similarly, previous affiliated status will not in any way influence FFAR staff, Advisory Councils, or Board of Directors when reviewing and evaluating any concepts or proposals submitted to FFAR for consideration, review or approval. However, FFAR recognizes that an organization that has affiliated status with FFAR and later decides to seek grant support from FFAR may create a real or perceived conflict of interest. Therefore, if an affiliated organization seeks such support, FFAR shall automatically revoke the organization's affiliated status and terminate this Agreement. It is the responsibility of the Affiliated Organization to notify FFAR if a concept or proposal is submitted to FFAR for funding consideration. This notification must be made in writing to the FFAR primary and communication contacts included in the Agreement within five (5) business days of the concept or proposal submission. If FFAR is not notified and learns of a submission by an affiliated organization through other means (How We Work or Proposal Central submissions, for example) FFAR will revoke the affiliated status immediately and notify the organization in writing of its violation of this Agreement.

If either FFAR or the organization revokes an organization's affiliated status and thereby terminates this Agreement, a notification to remove all use of the other's name and logo from electronic and future printed materials shall be issued to the primary and communication contacts of the other party to this Agreement, and such notice shall be complied with promptly.

**NONTRANSFERABILITY; NO JOINT VENTURE.** This affiliation is not transferable. Nothing contained herein shall be construed in any manner to imply or create a relationship between FFAR and you as partners, joint venturers or agent. You shall not act in any manner as our agent or representative.

**AUTHORITY; COMPLIANCE WITH APPLICABLE LAW.** You represent and warrant that you have full power and authority to enter into this agreement, and that all activities conducted hereunder shall be in full



compliance with the requirements of all applicable federal, state and local laws, regulations and ordinances.
